With reference to the above enquiry I have visited the site and had an opportunity to investigate the relevant issues, including taking advice from the Council's Conservation Officer.

The development namely, the porous hard surface and associated landscaping in front of the listed building, constitutes permitted development as set out by Class F, Part 1, Schedule 2 of the Town and Country Planning (General Permitted Development) Order 2015 (as amended). The works do not require listed building consent. Therefore, planning permission from Guildford Borough Council is not required.

No further planning enforcement action can be taken and our case will be closed.
